## **SNF Provider Preview Reports - Now Available**

The Skilled Nursing Facility (SNF) Provider Preview Reports have been updated and are now available. These reports contain provider performance scores for quality measures, which will be published on <a href="Care">Care</a> and <a href="Provider Data Catalog">Provider Data Catalog</a> (PDC) during the <a href="July 2022">July 2022</a> release.

The data contained within the Preview Reports are based on quality assessment data submitted by SNFs from Quarter 4, 2020 through Quarter 3, 2021. This release also resumes the reporting of all claims-based measures. Due to the COVID-19 reporting exceptions, the claims-based measures have been calculated excluding Quarter 1 and Quarter 2 2020 data from measure calculations. The data for the claims-based measures will display data from Quarter 3, 2019 through Quarter 4, 2019 and Quarter 3, 2020 through Quarter 2, 2021 for this release.

Lastly, a new claims-based measure (SNF Healthcare-Associated Infections (HAI) Requiring Hospitalization) will be publicly reported on Care Compare and PDC beginning with the July 2022 release and is reflected within the Preview Reports. The data for the SNF HAI measure will display data from Quarter 4, 2018 through Quarter 3, 2019 for this release.

Providers have until <u>May 30, 2022</u> to review their performance data. Corrections to the underlying data will not be permitted during this time. However, providers can request Centers for Medicare & Medicaid Services (CMS) review of their data during the preview period if they believe the quality measure scores that are displayed within their Preview Reports are inaccurate.

To locate the SNF QRP Provider Preview reports, please follow these steps below:

 Log into the CMS Network (CMSNet) using the CMSNet login credentials.

- 2. Log into the Certification and Survey Provider Enhanced Reports (CASPER) Reporting application using the Quality Improvement and Evaluation System (QIES) login credentials.
- Select the Folders button from the menu bar in CASPER and a list of your folders will display.
- 4. Select the facility-specific, non-Validation Report (non-VR) folder. These folders will be named in the following manner:

For Nursing Home-based SNFs:

[State Code] LTC [Facility ID] (i.e., MD LTC XYZ123)

For Swing Bed units:

[State Code] SB [Swing Bed ID] (i.e., TX SB ABC987)

- 5. The Preview Reports are listed in descending order by Date Requested within this folder.
- 6. Select the desired preview report link to view the report.

## Care Compare April Refresh of SNF QRP Data – Now Available

The April 2022 refresh of the Skilled Nursing Facility (SNF) Quality Reporting Program (QRP) data is now available on <u>Care Compare</u> and <u>Provider Data Catalog (PDC)</u>.

The data are based on quality assessment data submitted by SNFs to Centers for Medicare & Medicaid Services (CMS) from **Quarter 3, 2020 through Quarter 2, 2021.** The data for the claims-based measures will continue to display **Quarter 4, 2017 through Quarter 3, 2019** data for this refresh while CMS performs additional measure analyses.
