### What is RAVEN-SB?

RAVEN-SB is a computerized data entry system for swing bed facilities that offers users the ability to collect SB-MDS assessments in a database and transmit those assessments in CMS standard format to the National Assessment Collection Database. The data entry software imports and exports data in standard SB-MDS record format, maintains facility, patient, and employee information, enforces data integrity via rigorous edit checks, and provides comprehensive on?line help. It includes a data dictionary, RUG-III and HIPPS code calculators.

### What Kind of Computer Do I Need?

This software requires a Pentium 200 Mhz or better processor with a Microsoft Windows 95, 98, NT, 2000, or XP operating system. Sixteen megabytes of RAM are required; 22 megabytes are recommended. A minimum of 40 megabytes of hard disk space is needed for installation. The software is available by downloading it from this web site.
