Physicians Billing for Technical Component of Advanced Diagnostic Imaging Must be Accredited

Beginning Jan 1, 2012, suppliers furnishing the technical component of advanced diagnostic imaging services for which payment is made under the physician fee schedule must be accredited by a CMS-designated accreditation organization. In the case where a physician chooses to contract out those services to an accredited mobile unit, the physician must be accredited in order to bill Medicare for such services.

Hospital Providers are Excluded from the Advanced Diagnostic Imaging Accreditation Requirement

For Advanced Diagnostic Imaging furnished in a hospital outpatient setting, hospital outpatient departments would bill for the technical component of the procedure and be paid under Outpatient Prospective Payment System (OPPS). The physician would bill separately for the professional component and be paid under the Physician Fee Schedule for professional service.

The Medicare Improvements for Patients and Providers Act of 2008 (MIPPA) required all suppliers that are paid under the Physician Fee Schedule and furnishing the technical component of certain advanced diagnostic imaging to be accredited by January 1, 2012. For more information, please visit

National Provider Call on Accreditation Requirements for Advanced Diagnostic Imaging Technical Suppliers

Thu June 23, 2:30-4pm ET

CMS will host a national provider call on the upcoming mandatory accreditation program for all suppliers that furnish the technical component of advanced diagnostic imaging. Subject matter experts will discuss what the requirements are to meet the Sun Jan 1, 2012, deadline; who these requirements effect; and how to become accredited. CMS will update information previously discussed on Open Door Forums that will streamline the requirements.

The target audience for this call includes physician office staff and all Medicare fee-for-service providers; the agenda will include:

- the law;
- deadlines;
- suppliers effected;

- the enrollment process; and

Accreditation Deadline for Advanced Diagnostic Imaging Approaching – Sun Jan 1

Are you a Medicare provider or supplier that furnishes the technical component of advanced diagnostic imaging (ADI) services?

(ADI procedures include MRI, CT, nuclear medicine imaging, and positron emission tomography. X-ray, ultrasound, fluoroscopy, and Hospital Outpatient procedures are excluded.)

As directed by the *Medicare Improvements for Patients and Providers Act of 2008 (MIPPA)*, all providers and suppliers of the technical component of ADI who bill Medicare under the Physician Fee Schedule for these services must be accredited by *Sun Jan 1, 2012*. *Those not accredited by that deadline will not be able to bill Medicare until they become accredited.* (The technical component of ADI services includes the performance of such imaging procedures, not their subsequent interpretation.)

CMS has selected three organizations to perform the accreditation of Advanced Diagnostic Imaging providers and suppliers. Those seeking accreditation should note that the process may take up to five months to complete, so should be sure to begin the process as soon as possible.

Details of Accreditation Requirements for Advanced Diagnostic Imaging – Sun Jan 1 Deadline

If you’re a provider or supplier that furnishes the technical component of advanced diagnostic imaging (ADI) services and bill Medicare under the Physician Fee Schedule for these services, you should know that you must be accredited by *Sun Jan 1, 2012*. *Those not accredited by that deadline will not be able to bill Medicare until they become accredited.*

For those planning on seeking accreditation to continue performing the technical component of ADI services, know that accreditation is dependent on the demonstration of quality standards, including (but not limited to):

- Qualifications and responsibilities of medical directors and supervising physicians;
- Qualifications of medical personnel who are not physicians;
- Procedures to ensure that equipment used meets performance specifications;
- Procedures to ensure the safety of beneficiaries;
- Procedures to ensure the safety of person who furnish the imaging; and
- Establishment and maintenance of a quality assurance and quality control program to ensure the reliability, clarity and accuracy of the technical quality of the image.

Additionally, the accreditation process may include:

- Un-announced, random site visits;
- Review of phantom images;
- Review of staff credentialing records and maintenance records;
- Review of beneficiary complaints and patient records;
- Review of quality data and ongoing data monitoring; and
- Triennial surveys.

Providers Not Required to Supply Advanced Diagnostic Imaging (ADI) Certification Information via Enrollment Process

In January 2012, all Part B suppliers including physicians, and non-physician practitioners performing the technical component of advanced diagnostic imaging services—also known as ADI—who are paid under the Medicare Physician Fee Schedule will need to be accredited by one of the CMS-approved accrediting organizations. The accreditation organization will transmit all necessary data to CMS on an ongoing basis. Your Medicare billing contractor will receive these data from CMS. *Due to this file being received at CMS from the accrediting organizations, it is not necessary for the providers to supply the ADI information on their respective 855 form(s) or in the PECOS enrollment system.*

Reminder: When submitting your information to the accrediting organization, make sure you provide the NPI that you used to register the legal business name of the facility in the National Plan and Provider Enumeration System (NPPES). If you provided the incorrect NPI, please notify your accrediting organization as soon as possible.

Reminder: Technical component of Advanced Diagnostic Imaging Accreditation Requirements Effective Sun Jan 1, 2012

Suppliers of the technical component of Advanced Diagnostic Imaging that are billing with a service date on or after Sun Jan 1, 2012 must evidence an active accreditation date for diagnostic imaging of CPT codes attached to an MRI, CT, and Nuclear Medicine claim. The professional component claims are not affected by the accreditation requirements and must be processed as usual.
