Affordable Care Act

Section 3004 (a)

- CMS to establish quality reporting program for long-term care hospitals (LTCHs):
 - Providers must submit data on selected quality measures for fiscal year 2014 and subsequent fiscal years
 - Noncompliance will result in 2% reduction in annual payment update (APU)
 - Selected measures affecting APU to be published by CMS no later than October 1, 2012
 - CMS directed to establish procedures (no date specified) to make data available to the public and allow providers to review data before publication

Reporting Data on Select Quality Measures

- CMS, with input from stakeholders and the public, selects quality measures for the LTCH Quality Reporting Program.
- Data submitted by LTCHs will be used to calculate the clinical quality measures that are in effect during the fiscal year.

Stakeholder Engagement in the Quality Measure Development Process

- CMS held Special Open Door Forum, Listening Session and LTCH Technical Expert Panel (TEP) meetings to engage stakeholders:
 - CMS Listening Session: November 15, 2010
 - Special Open Door Forum: December 16, 2010, September 21, 2011
 - LTCH TEP meetings: January 31, July 6–7, September 27, 2011, March 8, 2012, ongoing TBD

Quality Measures for FY 2014 LTCH Quality Reporting Program Payment Determination

- In the FY 2012 IPPS/LTCH PPS final rule (76 FR 51743 through 51756), published on August 18, 2011, CMS finalized three quality measures for the FY 2014 LTCH Quality Reporting Program Payment Determination:
 - Catheter-associated urinary tract infections (National Healthcare Safety Network (NHSN) Catheter-Associated Tract Infection (CAUTI) Outcome Measure) (NQF #0138)
 - Central line catheter-associated bloodstream infections (National Healthcare Safety Network (NHSN) Central Line-Associated Bloodstream Infection (CLABSI) Outcome Measure) (NQF #0139)
 - Percentage of residents with pressure ulcers that are new or have worsened (NQF #0678)

- **October 1, 2012:** Data collection begins for patients admitted on or after October 1, 2012
- **October 1, 2013:** Payment reduction applies to FY2014 Medicare FFS payments for failure to submit quality reporting data
