## January 2006 Non-Outpatient Prospective Payment System (Non-OPPS) Outpatient Code Editor (OCE) Specifications Version 21.1

### Provider Types Affected

Providers billing Medicare fiscal intermediaries (FIs) for outpatient services that are not paid under the Outpatient Prospective Payment System (OPPS)

### Provider Action Needed

This article is based on Change Request (CR) 4236, which informs your fiscal intermediary (FI) that the January 2006 Non-OPPS OCE has been updated with new additions, changes, and deletions to Healthcare Common Procedure Coding System (HCPCS) codes and procedure codes in order to ensure correct billing.

### Background

The Non-OPPS OCE is used to process bills from hospitals not paid under the OPSS, and Change Request (CR) 4236 updates the Non-OPPS OCE with new additions, changes, and deletions to Healthcare Common Procedure Coding System/Current Procedural Terminology, Fourth Edition (HCPCS/CPT-4) codes.
