**A. Background:** The Centers for Medicare & Medicaid Services' (CMS) goal is to identify and remove any on-request obsolete jobs (i.e., jobs that no longer meet the needs of the business owner). The removal of on-request jobs reduces (1) System complexity and makes future maintenance easier and more efficient; (2) Processing and storage costs at the Virtual Data Centers; and (3) Processing and storage costs at the MACs by discontinuing the need to warehouse these jobs at their local data centers. CMS will issue a separate CR in which FISS will be directed to remove on-request obsolete jobs from the shared system. This CR is subsequent to CR9566.

**B. Policy:** There are no legislative or regulatory policies associated with this CR.
