Specifically, the Enterprise Data Centers (EDCs) send files for each shared system that are based on the copybooks the shared systems maintainers currently provide to the IDR Shared Systems Team. Once files are received, the Centers for Medicare & Medicaid Services (CMS) requires the IDRSS to perform a file consistency validation on each file sent by the shared systems prior to accepting the file and to retain the files at the Baltimore Data Center (BDC).

The purpose of this Change Request (CR) is to make necessary changes to the shared systems daily file feed to accommodate ambulance data so that it will populate in the IDRSS. This CR also provides the Shared System Maintainers hours necessary to assist the IDRSS in the improvement of the data dictionaries.
