I. GENERAL INFORMATION

A. Background: The Medicare Administrative Contractors (MACs) will all have new Healthcare Integrated General Ledger Accounting System (HIGLAS) Organization in the R12 HIGLAS environment. Tested HIGLAS conversion code will be utilized to transition the A and B MACs from the existing R11 HIGLAS environment. Financial Reconciliation and Reporting for each of these HIGLAS transitions will be performed by the AIS Contractor and supported by the MACs. The R12 upgrade transitions will begin in June 2015.

The HP Shared Systems (FISS & MCS) shall also support the transition to from the R11 to the R12 production environments.

The Medicare Administrative Contractors for A/B MAC Jurisdictions below will need to assess the impact of the effort defined in this CR:

- 1. Noridian HealthCare Solutions, Inc. A/B MAC for Jurisdictions JE and JF.

The Part A and Part B Shared Systems Maintainers will support the change of HIGLAS Organization and workload numbers required for the R12 HIGLAS Upgrade and ensure that daily interface files shall be

transferred from the A/B MACs' existing Virtual Data Center (VDC) to HIGLAS.

The A/B MAC staff and end users shall be granted the same security access, in the new Organization as they had in a previous HIGLAS Organization, assuming it does not violate any security or segregation of duty rules. Access in the decommissioned HIGLAS Organizations will be changed to read only.

The incumbent VDC shall establish and support the Unit Acceptance Testing (UAT) Region and Production Region for both the Part A and Part B operating systems. The A/B MAC will have the responsibility of performing requests for access changes as defined above, participating in a weekly status meeting, closing out Loans and reestablishing same as part of the HIGLAS Organization transition in addition to supporting Production Cutover Activities.

The incumbent VDC shall insure files are updated appropriately for entities where data is exchanged, via batch requests for access changes as defined above, participating in a weekly status meeting, and support Production Cutover Activities.

The incumbent VDC shall insure file names (organization and workload numbers) are updated appropriately for entities where data is exchanged, via batch.
