I. GENERAL INFORMATION

A. Background: The Centers for Medicare & Medicaid Services is requesting that Multi-Carrier System (MCS) maintainer implement a process of recalling purged claim history records back into active system use. A/B Medicare Administrative Contractors will use this process to support claim reopening and other claim adjustment processing. The change will improve the efficiency of the process in terms of files, system memory and job runtime. To provide context, claims in the MCS application are periodically archived from the MCS online claim history files. Archiving reduces resource utilization and maintains system performance. Archived claim history records are only available for post-payment processing after being recalled from the claim archive files. When the business need arises, archived claim records may be recalled and added back to the MCS online claim history files, where they are available for adjustment processing.

This change will significantly reduce the overhead, complexity, and run-time associated with Archived History Pull Request jobs. The change in architecture eliminates the need to obtain large amounts of storage for each job to execute; it mitigates the risk of incurring cycle abends when the system does not have the memory available to accommodate the large storage requests. Run-time and Central Processing Unit use for each job will be reduced by eliminating the need to evaluate every purged history claim for a given Provider Pull Request. The change can mean a difference between processing a few thousand purged claim records versus processing hundreds of thousands. The change also eliminates the need for the Virtual Data Centers (VDCs) to maintain 21 generations of every purged history receipt-year file. There are currently 24 different purged history receipt-year files, each one requiring 21 cataloged generations, for a total of 504 cataloged files. This enhancement eliminates the need to retain this large number of cataloged files, and simplifies on-going maintenance of the 22 batch jobs that process against the purged history data.
