I. SUMMARY OF CHANGES: The Centers for Medicare & Medicaid Services (CMS) requests that the Multi-Carrier System (MCS) Maintainer update the claim tracking and logging systems for CCEM. Logging is a method used for debugging or capturing performance and error information from an application during execution. Logging works by having log statements inserted into application code. When an anomalous processing condition is encountered, the related processing information is written to a log file for later analysis and debugging purposes.

The CCEM Java application currently uses the Log4j utility, version 1.2.17. A newer version of the Log4j logger named Log4j 2 is now available. Log4j 2 contains next-generation lock-free Asynchronous Loggers. In multi-threaded scenarios Asynchronous Loggers have 10-times higher throughput and orders of magnitude lower latency than Log4j. It provides a real improvement in efficiency for logging application performance.

By moving to the Log4j 2 version of the logging utility, CCEM will see improved performance for logging. The change also moves the applications to using the new version of the logging utility which is recommended for long-term application sustainability.

The Simple Logging Facade for Java (SLF4J) serves as a simple facade or abstraction for various logging frameworks. SLF4J allows the end-user to plug in the desired logging framework at *deployment* time.

A separate Healthcare Integrated General Ledger Accounting System (HIGLAS) Change Request (CR) will be issued for MCS and Fiscal Intermediary Shared System (FISS) for these Java changes.
