

Medicare Ground Ambulance Data Collection System (GADCS): Reporting Expenses for Contracted Services

Selected ground ambulance organizations must collect and report information to the Centers for Medicare & Medicaid Services (CMS) via the Medicare Ground Ambulance Data Collection System (GADCS). For more information, see CMS' GADCS Frequently Asked Questions document.

Many organizations contract **select functions** of their operations. Common examples include:



Dispatch: Organizations may pay a monthly fee to a dispatch service instead of employing dispatchers directly.



Vehicle maintenance: Organizations may take their vehicles to a mechanic instead of or in addition to employing mechanics directly.



Billing: Organizations may contract a billing organization instead of doing billing in-house.

In some instances, organizations may contract out core ambulance functions including:



EMT Labor (excluding Medical Direction): Organizations may contract all EMT/Response staff instead of employing them directly.



Broader Ground Ambulance Services: Organizations may contract broader response capabilities including ambulance units and service hours.

You will indicate your organization's contracting scenario in **Section 2**, **Organizational Characteristics**, **Question 18** of the GADCS ("Did your organization contract out core ground ambulance functions, like EMS responses, EMT staffing, or provision of ambulances during its 12-month data collection period?"). Your answer determines the instructions you will see later in the GADCS. Details for each scenario are below.

Example 1. Contracts out only select functions





The organization contracts janitorial services, dispatch, billing, and medical direction, but directly employs EMTs and administrative staff.
