Open Payments System Quick Reference Guide

Creating an Open Payments Physician or Non-Physician Registration

Introduction

This guide provides an overview of the physician and non-physician practitioner (NPP) registration process in the Open Payments system.

Prerequisites

- User is registered in the Centers for Medicare & Medicaid Services (CMS) Identity Management system (IDM) and has obtained access to the Open Payments system
- Required information for registration includes at least one active State License and corresponding Taxonomy Code

Actions

Registering as a Physician or Non-Physician Practitioner

- 1. Log in to the CMS Enterprise Portal at <u>https://portal.cms.gov</u> using IDM credentials and navigate to the Open Payments home page.
- 2. On the Open Payments home page, select "Create My Profile."
- 3. On the "Create Profile" page, scroll to the bottom of the page and select the "Start Profile" button.
 - a) A list of the information required for registration is available in the "Required Information for Profile creation" quick reference guide. This guide is available on the "Create

Profile" page and also on the Resources page of the Open Payments website (<u>https://www.cms.gov/openpayments/about/resources.html</u>).

- 4. On the "Select Profile Type" page, select the "Physician or Non-Physician Practitioner" radio button and select the "Continue" button to begin the registration process.
- 5. Enter your personal information. Required fields are marked with an asterisk. Required fields must be completed to proceed.



- 6. Enter your physician or NPP information on the "Covered Recipient Details" page. Required fields are marked with an asterisk. Required fields must be filled to proceed. Note the following:
 - b) If you are registered with the National Plan and Provider Enumeration System (NPPES), ensure that the name provided for registration is the same as it appears in NPPES.
 - c) If you have a National Provider Identifier (NPI), you are required to enter it exactly as listed in NPPES for the current calendar year.
 - d) Enter at least one active State License.
 - e) For each license or taxonomy code entered, select the "Add" button to save the information to the profile. Without selecting the "Add" button, the information will not be saved.
- 7. Nominate an authorized representative, if desired.
 - a) You may nominate an authorized representative during initial registration or at a later time.
 - b) Authorized representatives can take certain actions in the Open Payments system on behalf of their associated physician or NPP. You may only have one authorized representative. An authorized representative may represent as many physicians or NPPs as they wish.
 - c) An authorized representative can be another physician or NPP, an office manager, or a practice manager. You cannot nominate yourself as an authorized representative.
 - d) Refer to the quick reference guide "Nominating a Physician or NPP Authorized Representative and Accepting/Rejecting Nominations" for more information.
- 8. Review the information on the "Review and Submit Profile" page and select the "Submit" button to complete registration.

Once your profile has been submitted, the system will vet your profile using the information submitted to verify you are a covered recipient physician or NPP. You will receive an email confirming vetting success or failure. No system actions can be performed until vetting has been successfully completed. • Once vetting is successful, your name and NPI referenced in the profile cannot be changed. If edits to either of these fields are required after vetting is successful, contact the Open Payments Help Desk for assistance.

• Review the data submitted about you and affirm it is accurate or if necessary dispute the data.
