## Comprehensive ESRD Care Model (CEC Model) Fact Sheet

## **Overview**

In October 2015, the Centers for Medicare & Medicaid Services (CMS) launched a new accountable care organization (ACO) model called the Comprehensive ESRD Care (CEC) Model. Dialysis facilities, nephrologists, and other providers joined together to form ESRD Seamless Care Organizations (ESCOs) that are responsible for the cost and quality of care for aligned beneficiaries. CMS will partner with health care providers and suppliers to test the effectiveness of a new payment and service delivery model in providing beneficiaries with person-centered, high-quality care. The Model builds on Accountable Care Organization experience from the Pioneer ACO Model, Next Generation ACO Model, and the Medicare Shared Savings Program to test Accountable Care Organizations for ESRD beneficiaries. This model aligns with the Administration's goal of tying 50 percent of traditional, or fee-for-service, Medicare payments to alternative payment models, such as ACOs, by the end of 2018.

For the 2016 performance year, 13 ESCOs participated in the CEC Model. For the 2017 performance year, 24 ESCOs joined the model, for a total of 37 participating ESCOs.

### **Selected Organizations**

The CEC Model represents a variety of geographic regions and both Large and Non-Large Dialysis Organizations, which were selected by fulfilling specific eligibility criteria outlined in the Request for Applications found at the <u>CEC Model web page</u>. These organizations were selected through an open and competitive process from a large applicant pool that included many qualified organizations.
