#### I. GENERAL INFORMATION

This attachment provides information on the updates to the payment rates used under the PPS for SNFs, for FY 2012, as required by statute. The update can be found in Pub. 100-04, Medicare Claims Processing Manual, chapter 6, section 30.7.

- **A. Background:** Annual updates to the PPS rates are required by §1888(e) of the Social Security Act, as amended by the Medicare, Medicaid, and SCHIP Balanced Budget Refinement Act of 1999 (the BBRA), and the Medicare, Medicaid and SCHIP Benefits Improvement and Protection Act of 2000 (the BIPA) and the Medicare Prescription Drug, Improvement, and Modernization Act of 2003 (the MMA), relating to Medicare payments and consolidated billing for SNFs.
- **B.** Policy: The Centers for Medicare and Medicaid Services (CMS) published the SNF payment rates for FY 2012 (that is, beginning October 1, 2011 through September 30, 2012), in the **Federal Register** on August 8, 2011 (76 FR 48486). The update methodology is identical to that used in the previous year and will include the MMA reimbursement for beneficiaries with AIDS. This update includes new case-mix indexes using the recalculated case-mix adjustments based on actual RUG-IV data. The statute mandates an update to the Federal rates using the latest SNF full market basket adjusted for productivity. The payment rates will be effective October 1, 2011.
