I. GENERAL INFORMATION

A. Background: During the Stage 2 of NPI implementation, the shared systems will begin receiving NPIs on paper and electronic claims. Effective with the October 2006 Release, the FISS and MCS shared systems will begin to send NPIs received to HIGLAS to update the HIGLAS Provider and Customer data bases. The HIGLAS will not begin to return NPIs to shared systems for payments until a future release. HIGLAS interfaces are impacted during this Stage and only for those Medicare contractors on HIGLAS.

B. Policy: The administrative simplification provisions of the Health Insurance Portability and Accountability Act (HIPAA) of 1996 (P.L. 104-191) require the Secretary of Health and Human Services to adopt a national standard identifier for covered health care providers for use in the health care system. The Centers for Medicare and Medicaid Services (CMS) published a Final Rule on January 23, 2004 that announced the National Provider Identifier (NPI) as the standard identifier.
