#### I. GENERAL INFORMATION

#### A. Background:

**A.**The latest package of CCI edits, Version 19.0, effective January 1, 2013, will be available via the CMS Data Center (CDC). The Centers for Medicare & Medicaid Services developed the National CCI to promote national correct coding methodologies and to control improper coding that leads to inappropriate payment in Part B claims. A test file will be available on or about November 2, 2012, and a final file will be available on or about November 17, 2012.

Version 19.0 will include all previous versions and updates from January 1, 1996, to the present and will be organized in two tables: Column 1/Column 2 Correct Coding Edits and Mutually Exclusive Code (MEC) Edits.

**B. Policy:** The coding policies developed are based on coding conventions defined in the American Medical Association's Current Procedural Terminology manual, national and local policies and edits, coding guidelines developed by national societies, analysis of standard medical and surgical practice, and review of current coding practice.
