

Notes for 2018 PUF files

California (CA):

Based on CA's review of the data CMS received from NAIC, the following modifications were made:

Plan PUF and Benefits PUF:

- Replaced NAIC data with that provided by CA for the following issuer IDs: 10544, 18126, 27603, 40513, 47579, 67138, 70285, 84014, 92499, 92815, 93689, 99110

Business Rules PUF:

- CA does not use the business rules template, so there is no Business Rules PUF file for CA.

District of Columbia (DC):

Service Area PUF:

- DC does not use the service area template, so there is no Service Area PUF file for DC.

Massachusetts (MA):

Based on MA's review of the data CMS received from NAIC, the following modifications were made:

Service Area PUF:

- Removed duplicate records for BCBS DEN
- Added missing service area for Franklin county for Tufts Direct

Network PUF:

- Removed duplicate records for HPHC, NHP and Tufts Premier

Rate PUF:

- Data includes two versions of Fallon's non-group silver plans, with rates before and after the federal CSR withdrawal.
- Adjusted Fallon's small group rates to reflect revised rates
- Fixed discrepancies in HNE and NHP non-group and small group rates
- Deleted rates for plans which were not sold on the exchange for BMCHP, Fallon, HNE, HPHC, and NHP
- plans identified by MA as "unloaded" silver plans for BMCHP, Fallon, HNE, Deleted rates for NHP, and Tufts Direct

Plan PUF and Benefits PUF:

- Deleted plans which were not sold on the exchange for BMCHP, Fallon, HNE, HPHC, and NHP
- Deleted plans identified by MA as "unloaded" silver plans for BMCHP, Fallon, HNE, NHP, and Tufts Direct

Maryland (MD):

Business Rules PUF:

- MD did not request a business rules template from their issuers this year, so there is no Business Rules PUF file for MD.

New York (NY):

General:

- The files and issuers provided for NY's Small Business Health Options Program (SHOP) is a reflection of the issuers participating in the exchange at the time in which CMS pulled the data from NAIC. It does not include additional issuers who entered New York's SHOP, or expanded their offerings therein, due to NY's shift in PY 2018 to a direct enrollment process. The additional issuers are: CDPHO, Emblem, HealthFirst, Oscar (all new); MVP (expanded). For information on those plans, please contact the issuers directly.

Vermont (VT):

Service Area PUF and Network PUF:

- VT does not use either the service area template nor the network templates, so there are no Service Area or Network PUF files for VT.

Washington (WA):

Based on the WA's review of the data CMS received from NAIC, the following modifications were made: Plan PUF, Benefit PUF and Rate PUF:

- Updated NAIC data to reflect the changes provided by WA, by issuer and plan. There were multiple updates across many variables in these PUF files.
