 October 1, 2013 – Compliance date for implementation of ICD-10-CM (diagnoses) and ICD-10-PCS (procedures)



### **ICD-10** Implementation

- ICD-10-CM (diagnoses) will be used by all providers in every health care setting
- ICD-10-PCS (procedures) will be used only for hospital claims for inpatient hospital procedures
- ICD-10-PCS will not be used on physician claims, even those for inpatient visits



- No impact on Current Procedural Terminology (CPT) and Healthcare Common Procedure Coding System (HCPCS) codes
- CPT and HCPCS will continue to be used for physician and ambulatory services including physician visits to inpatients



### ICD-10 Implementation

- Single implementation date of October 1, 2013 for all users
- Date of service for ambulatory and physician reporting
  - Ambulatory and physician services provided on or after 10-1-2013 will use ICD-10-CM diagnosis codes
- Date of discharge for hospital claims for inpatient settings
  - Inpatient discharges occurring on or after 10-1-2013 will use ICD-10-CM and ICD-10-PCS codes



 ICD-9-CM codes will not be accepted for services provided on or after October 1, 2013

 ICD-10 codes will not be accepted for services prior to October 1, 2013

ICD-9 Notice: The International Classification of Diseases, 9thEdition, Clinical Modification (ICD-9-CM) is published by the United States Government. A CD-ROM, which may be purchased through the Government Printing Office, is the only official Federal government version of the ICD-9-CM. ICD-9-CM is an official Health Insurance Portability and Accountability Act standard.



### ICD-10 Differences

- ICD-10 codes are different from ICD-9-CM codes
  - They provide greater detail in describing diagnoses and procedures
  - There are more ICD-10 codes than ICD-9-CM codes
- ICD-10 codes are longer and use more alpha characters
- System changes required to accommodate ICD-10 codes

### Tools in Converting Codes

- General Equivalence Mappings (GEMs) assist in converting data from ICD-9-CM to ICD-10
- Forward and backward mappings
  - Information on GEMs and their use <u>http://www.cms.gov/ICD10</u> (click on ICD-10-CM or ICD-10-PCS to find most recent GEMs)



### **Converting Data**

- GEMs are not a substitute for learning how to code with ICD-10
- For some small conversion projects it may well be quicker and more accurate to use ICD-10 code books instead of GEMs



- Annual ICD-9-CM and ICD-10 code updates make transition planning difficult
- Vendors, system maintainers, payers, and educators requested a code freeze



- Last regular, annual updates to both ICD-9-CM and ICD-10 will be made on October 1, 2011
- On October 1, 2012 there will be only limited code updates to both ICD-9-CM & ICD-10 code sets to capture new technology and new diseases
- On October 1, 2013 there will be only limited code updates to ICD-10 code sets to capture new technology and new diseases



- There will be no updates to ICD-9-CM on October 1, 2013 as the system will no longer be a HIPAA standard
- On October 1, 2014 regular updates to ICD-10 will begin

### The Challenges

 What? For each Lab NCD, translate the included ICD-9-CM codes and descriptions to ICD-10-CM versions.
 Update with changes to ICD-9-CM or ICD-10-CM codes and descriptions adopted prior to implementation.

 When? (A) Prepare preliminary versions of ICD-10-CM translations of Lab NCDs by end of January 2011 (for use in testing system functions); (B) Prepare ICD-10-CM versions for full ICD-10-CM implementation in 2013.



### **Objectives and Goal:**

- Translate all ICD-9-CM codes and descriptors in each Lab NCD's table of covered codes to the ICD-10-CM equivalents.
  - Translate any other ICD-9-CM codes that may appear in other areas of the Lab NCD Manual.
- Provide these translated tables to the contractor, so that the tables can be incorporated into the appropriate documents and shared systems files.
- (Goal) Allow consistent and 'seamless' transition of claims for providers of laboratory test services.





### Translating ICD-9-CM $\rightarrow$ ICD-10-CM

Final Step: Check that Descriptors are Consistent

**Does the ICD-9-CM descriptor ...** 

... match the ICD-10-CM descriptor?

### **Example:**

121.3, "Fascioliasis" → B66.3, "Fascioliasis"



### Flags define I-9 -> I-10 Relationships

- One-to-One
  - One ICD-10-CM code for a given ICD-9-CM code
  - Example: [B66.3, "Fascioliasis"] ↔ [121.3, "Fascioliasis"]
  - Flags: "00000" (means: translation is not approximate)
- Many-to-One
  - Multiple ICD-9-CM codes for a given ICD-10-CM code.
  - Flags: "10000" (means: translation is approximate)
- One-to-Many
  - One ICD-9-CM code with multiple ICD-10-CM codes.
  - Flags: "10000" (means: translation is approximate)



- One-to-Many: for one ICD-9-CM code 017.30, "Tuberculosis of eye" there are six linked ICD-10-CM codes:
  - A18.50, "Tuberculosis of eye, unspecified"
  - A18.51, "Tuberculosis episcleritis"
  - A18.52, "Tuberculosis keratitis"
  - A18.53, "Tuberculosis chorioretinitis"
  - A18.54, "Tuberculosis iridocyclitis"
  - A18.59, "Other tuberculosis of the eye"



### GEM Links: Many to One

- Many-to-One: An example: for the 21 ICD-9-CM codes describing tuberculosis (TB) of the lung in various stages, such as:
  - 011.20, "TB of lung with cavitation, unspecified",

there is one linked ICD-10-CM code:

• A15.0, "TB of lung"



### Translator's Choice

- Picking the most appropriate match(es) from the multiple alternative ICD-10-CM codes suggested by GEM-based translation may be challenging.
- Sometimes, it helps to review the descriptors for some of these alternative ICD-10-CM codes to pick the appropriate one(s) for a given Lab NCD.
- While trying to avoid 'code explosion', we have tended to include any potential ICD-10-CM code(s) suggested by a GEMbased translation if clinically appropriate.
  - While conceding that some judgment must be used in this selection process, we want to avoid using the ICD-9-CM → ICD-10-CM translation process to bypass the normal process for updating Lab NCDs.



### Extending Translation to Each Lab NCD ...

- **1.** List all currently covered ICD-9-CM codes for that Lab NCD. Ensure that list is complete. (Example 1)
- Use most current publicly available General Equivalence Mapping (GEM) files for both forward and back translation of each covered ICD-9-CM code. (Example 2) Merge and de-duplicate forward and back translated versions.
- **3.** Compare each proposed ICD-9-CM and ICD-10-CM translation (incl. descriptors) for consistency. (Example 3)
- **4.** List all unique ICD-10-CM codes for that Lab NCD. (Example 4) in ICD-10-CM order.



### Final Product (part 2): ICD-10-CM Version of Codelist Module

- One of CMS' contractors takes the lists of covered ICD-10-CM codes for each of the Lab NCDs and prepares the 'codelist spreadsheet' which can be processed for use by the shared systems for claims processing.
- This phase of the translation process will test the new ICD-10-CM version of the 'codelist spreadsheet' to see if it works as part of the claims processing mechanisms.

# **OASIS** and Procedure Code Reporting

- OASIS-C data item M1012 asks the provider to list Inpatient Procedures and the associated ICD procedure code relevant to the plan of care.
- CMS recently determined that this data item is not going to be used for payment, quality measures or risk adjustment.



#### OASIS and Procedure Code Reporting

During the 4/13/11 Open Door Forum and in recent OASIS Qs and As, CMS instructed HHAs to answer M1012, but that any answer, including N/A or Unknown, is acceptable; the actual answer chosen is insignificant because it will not impact payment, measures or risk adjustment. Until further notice, agencies still need to answer the item and cannot leave it blank because technical specifications require an answer.



#### OASIS and Procedure Code Reporting

- CMS is awaiting OMB response regarding a plan to delete M1012 from the OASIS-C data set.
- A revision of the OASIS-C data set, including elimination of M1012 and accommodation for ICD-10 diagnosis codes will be prepared and submitted for OMB approval in preparation for the conversion from ICD-9 to ICD-10 on 10/1/2013.
