## **March 28, 2013**

CMS is restructuring its coordination of benefits (COB) and Medicare Secondary Payer (MSP) recovery activities.

This action will provide:

- Improved customer service for stakeholders
- Consolidated and streamlined data collection and recovery operations
- Value-added efficiencies and enhanced resource utilization

First, CMS will transition all Group Health Plan (GHP) recovery activity to a Commercial Repayment Center (CRC). The CRC will assume responsibility for GHP case work on May 13, 2013. The Medicare Secondary Payer Recovery Contractor will continue to perform liability insurance (including self-insurance), no-fault insurance, and workers' compensation (Non-Group Health Plan) recovery case work. At a later date, CMS will transition all COB and Non-Group Health Plan recovery activities to the Benefits Coordination & Recovery Center.
