**Frequently Asked Questions**

**IACS Access**

**Question 1:**

Our practice participated in the 2007 Physician Quality Reporting Initiative (PQRI), and we are anxious to register our security official (SO) in Individuals Authorized Access to CMS Services (IACS). Who do we contact if we have problems obtaining our SO role?

**Answer 1:**

If you need assistance with the Individuals Authorized Access to CMS Services (IACS) registration process (i.e. forgot ID, password resets, etc.), contact the External Users Services (EUS) Help Desk at 1-866-484-8049, TTY/TDD at 1-866-523-4759 (Monday-Friday 7:00 a.m.-7:00 p.m. EST) or via e-mail at [EUSSupport@cgi.com](mailto:EUSSupport@cgi.com).

**Question 2:**

What are the steps for an individual eligible professional or organization to access the 2007 PQRI Feedback reports?

## **Incentive Payment**

**Question 1:**

How was my incentive payment calculated?

**Answer 1:**

To determine how the incentive payment was calculated and to understand key terms used in PQRI analysis and documentation please refer to the following document: A Guide for Understanding the 2007 PQRI Incentive Payment. This can be found at:

**Question 2:**

What Remittance Advice Code (RAC) will be given with incentive payments?

**Answer 2:**

For paper checks, contractors will place an explanatory message on the P4R lump sum bonus payments that says: "This check is for a P4R payment." For electronic transmissions, provider adjustment code "LS" (lump sum) will appear in PLB03-1 on the outgoing 835.

**Question 3:**

Are PQRI incentive payments subject to offsets, if there are any?

**Answer 3:**

Yes, the lump-sum incentive payments are subject to offsets. Payments are made to the Tax ID (TIN) of the first PIN tied to that TIN. So if that initial PIN has an offset, carriers will apply it to the lump sum.

**Question 4:**

How will the 2007 PQRI 1.5 percent incentive payment be calculated? (*CMS PQRI FAQ 8262*)

**Answer 4:**

Participating physicians and other eligible professionals who successfully report as prescribed by the Tax Relief and Health Care Act of 2006, Division B, Title I, Section 101 may earn a 1.5% incentive payment, subject to a cap. The potential 1.5% incentive will be based on allowed charges for covered professional services: (1) furnished during the reporting period of July 1 through December 31, 2007, (2) submitted to the carrier or A/B MAC by February 29, 2008, and (3) paid under the Medicare Physician Fee Schedule (PFS). Because claims processing times may vary by time of the year and Medicare Carrier/Medicare Administrative Contractor (MAC), CMS will use an actuarial completion factor in the calculation of financial-incentive amounts to compensate for the claims submitted by professionals by February 29, 2008, but not yet processed by that date.

**Question 5:**

What services were included in the 1.5 percent lump-sum incentive payment for the 2007 Physician Quality Reporting Initiative? (*CMS PQRI FAQ 9338*)

**Answer 5:**

The potential 1.5% lump-sum incentive payment for the 2007 Physician Quality Reporting Initiative (PQRI) will be based on all allowed charges for covered professional services: (1) furnished during the reporting period of July 1, 2007 through December 31, 2007, (2) paid under the Medicare Physician Fee Schedule (PFS), (3) fully processed to final-action status by the final Friday in February, 2008, and (4) multiplied in the course of PQRI analysis by an actuarially-determined completion factor.

### **Feedback Reports – General Questions/Info**

**Question 1:**

When will 2007 Physician Quality Reporting Initiative (PQRI) provider feedback reports be made available to participating providers and what information will they contain? (*CMS PQRI FAQ 8274*)

**Answer 1:**

CMS confidential feedback reports are now available. The participant feedback reports contain reporting and performance information at the individual NPI level and aggregated at the TIN level.

**Question 2:**

Our group practice (Tax Identification Number or TIN) participated in the 2007 Physician Quality Reporting Initiative (PQRI). I am anxious to view my feedback report at the

individual (National Provider Identifier or NPI) level to see my quality reporting results and to see if I qualified for a lump-sum incentive payment.

**Answer 2:**

2007 feedback reports will be available to each practice, identified by Tax Identification Number (TIN) under which at least one eligible professional reported 2007 Physician Quality Reporting Initiative (PQRI) quality measures data. Reports available to the practice will include information on reporting rates, clinical performance, and incentives earned by individual professionals, with summary information on reporting success and incentives earned at the practice (TIN) level. Please see also CMS PQRI FAQ #8252, #9266, #9267. The incentive payment, aggregated at the TIN level, will be issued either electronically or via check to the TIN by the Carrier or A/B Medicare Administrative Contractor (MAC) in mid-July 2008.

**Question 3:**

We have multiple providers within our practice. Will we get a feedback report for each of the providers who participate in the Physician Quality Reporting Initiative (PQRI)? (*CMS PQRI FAQ 8275*)

**Answer 3:**

One 2007 PQRI feedback report will be prepared for each TIN. The group practice will be responsible for sharing NPI-level information with the appropriate professionals within the group practice.

**Feedback Reports – Not Found/Not Loading**

**Question 1:**

I am on the Physician Quality Reporting Initiative (PQRI) Portal and my 2007 PQRI feedback report will not display. Who should I contact?

**Answer 1:**

**Question 2:**

I am on the Physician Quality Reporting Initiative (PQRI) Portal and am unable to access my 2007 PQRI feedback report so I can download it. Who should I call for help?

**Answer 2:**

**Question 3:**

I have an authorized Physician Quality Reporting Initiative (PQRI) user role, but when I access the PQRI Portal system using my Individuals Authorized Access to CMS Computer Services (IACS) user name and password, the system tells me I do not have a feedback report under my Tax Identification Number (TIN). Why?

**Answer 3:**

For questions about accessing PQRI feedback reports, contact the QualityNet Help Desk at 1-866-288-8912. You may not have a report because of unsuccessful submission of valid quality-data codes (QDC). A QDC is considered valid for 2007 if it pertains to a 2007 PQRI quality measure and is submitted on a claim with the diagnosis and procedure codes that render the claim an opportunity to report the measure to which the QDC pertains, per the 2007 PQRI quality measure specifications. In order to receive a 2007 PQRI feedback report, at least one EP within the TIN must have submitted at least one valid quality-data code (QDC), identified with the EP's NPI, on at least one Part B Medicare claims for the 2007 PQRI reporting period (July 1-December 31, 2007).

Please review your records of the codes you submitted for the 2007 PQRI, including the remittance advice (RA) you received for PQRI QDC line items. If, after reviewing your documentation and the 2007 PQRI measure specifications and other information available on the CMS PQRI website, you still have questions about how your PQRI-related claims were processed, you may contact your current Carrier or A/B Medicare Administrative Contractor (MAC). **Question 4:**

I am an eligible professional who participated in the 2007 Physician Quality Reporting Initiative (PQRI). The security official (SO) within our group practice informed me that my individual feedback report information is available online. After accessing the PQRI Portal as part of my Taxpayer Identification Number's (TIN's) User Group, I was able to view my National Provider Identifier (NPI) Reporting Detail in Table 2. I referenced the 2007 PQRI Feedback Report User Guide (see <https://www.qualitynet.org/imageserver/pqri/documents/PQRI%20Reports%20User%20Guide.pdf>) and see that there is a third table which displays individual NPI performance information. Why is my Table 3 missing?

**Answer 4:**

Table 1 of the 2007 Physician Quality Reporting Initiative (PQRI) feedback report is only accessible at the Taxpayer Identification Number (TIN) level. It is up to the TIN to distribute PQRI feedback information. Each eligible professional (EP) who participated in 2007 PQRI will receive information in Table 2. Table 3 is not available at the NPI level if the eligible professional had no reported instances for any 2007 PQRI measures.

## Feedback Reports – Questions on Results

### Question 1:

My internal records indicate that I reported more 2007 Physician Quality Reporting Initiative (PQRI) quality-data codes than my feedback report shows. Who should I contact?

### Answer 1:

If Physician Quality Reporting Initiative (PQRI) participants work with a clearinghouse to process claims, contact the clearinghouse. Otherwise, contact your Contact carrier/MAC to review the remittance advice (RA)s.

### Question 2:

We have received our 2007 Physician Quality Reporting Initiative (PQRI) lump-sum incentive payment from our Medicare Carrier or A/B Medicare Administrative Contractor (MAC). After reviewing our online feedback report (packaged at the Tax Identification Number (TIN) level, we have questions on the amount of the incentive payment. Who should we contact?

### Answer 2:

Please see CMS PQRI FAQs #8234, #8262, #8419, and #8519 related to the 2007 PQRI incentive payment. If you have additional questions on your incentive payment amount at the Tax Identification Number (TIN) level, contact your current Medicare Carrier or A/B Medicare Administrative Contractor (MAC). ### **2007 PQRI feedback reports:**

Reports are now accessible through a secure, on-line mechanism

- Available beginning mid-July, 2008

- Adobe PDF format
- Include:
  - TIN-level reporting and financial information
  - Individual professional-level reporting & performance information
  - National-average performance comparison information

**To access 2007 PQRI feedback reports:**

Register in CMS security system Individuals Authorized Access to CMS Computer Services (IACS) to access reports

- Registration is free
- Allow time for processing

Register in IACS as an organization if you are:

- A group practice which receives Medicare payments on behalf of its members, or
- A solo eligible professional who will use one or more employee(s) to access PQRI.

**Note:** One feedback report will be prepared for each TIN. The group practice will be responsible for sharing NPI-level information with the appropriate professionals in the group practice.

Professionals who reassigned Medicare payments to a group practice should NOT register in IACS unless they are one of the individuals designated to do so by the group practice.

Register in IACS as an Individual Practitioner if you are:

- A solo eligible professional without employees who is paid directly by Medicare, or
- A solo eligible professional with one or more employees who is paid directly by Medicare and wants to access your PQRI feedback report personally (less time to approve, more automated)
