Key Points

- The effective date for CR3531 is January 1, 2005.
- The implementation date is January 3, 2005.
- CR3531 and MM3531 fully replace CR3366 and MM3366 (see links below).
- When patients are not entitled to, or have exhausted Part A benefits, Medicare will pay, under part B, for certain physician and certain non-physician medical and other health services that a participating hospital or SNF furnished to their inpatients.
- Some Fiscal Intermediaries (FIs) are paying for services under the 12X and 22X Type of Bill (TOB) that do not meet the definition of these inpatient Part B services. To address this, the standard Medicare systems must include an edit to ensure payment is made on 12X and 22X TOBs only for the services defined in Section 10, Chapter 6 of the *Medicare Benefit Policy Manual* as an inpatient Part B service.
- CR3531 updates edits regarding:
 - Revenue codes 024x (All inclusive ancillary services, removed from non-payable table for SNFs and hospitals inpatient Part B services);
 - 0634 (EPO under 10,000 units);
 - 0635 (EPO over 10,000 units);
 - 0379 (Other anesthesia, removed from non-payable table for SNFs and hospital inpatient Part B services);
 - 096x (Professional fees, removed from non-payable table for SNFs and hospital inpatient Part B services – Replaced with 0960, 0961, 0962, 0969);

- 0948 (Removed from non-payable table for SNFs and hospitals); and
- 22x (added as an applicable TOB for Diabetes Self Management Training (DSMT) services).
- Specific revenue codes that will never be paid are listed in CR3531. (See link below.)
