**SUBJECT:** June 30, 2009 Healthcare-Associated Infections Professional Stakeholder Meeting – For Your Information

**Memorandum Summary**

- On June 30, 2009, the Department of Health and Human Services (HHS) plans to gather its key partners in the Action Plan to Prevent Healthcare-Associated Infections to provide updates on the initiative and engage in a dialogue about potential next steps.
- The Recovery Act HAI initiatives, including the ASC HAI initiative, are distinct from, but consistent with the goals, objectives, and recommendations in the HHS Action Plan.
- We are sharing with you the information HHS provided to us so that you can, in turn, provide it to interested individuals in your areas and other organizations, as appropriate.
- The June 30<sup>th</sup> meeting is in Washington, DC. Future meetings may take place in Seattle, Denver, and Chicago.

As part of a national effort to prevent healthcare-associated infections (HAI), the Department of Health and Human Services (HHS) issued the Action Plan to Prevent Healthcare-Associated Infections in January 2009 ([www.hhs.gov/ophs/initiatives/hai/index.html](http://www.hhs.gov/ophs/initiatives/hai/index.html)) and solicited comments from interested stakeholder groups in support of a national HAI prevention effort. The Recovery Act HAI initiatives, including the ASC HAI initiative we have previously discussed with State Survey Agencies, are distinct from, but consistent with the goals, objectives, and recommendations in the HHS Action Plan.

In follow up to the HAI Action Plan, HHS plans to gather its key partners in the HAI prevention effort to provide updates on the initiative and engage in a dialogue about potential next steps. In order to maximize participation, we are sharing with you the information they provided to us so that you can, in turn, provide it to interested individuals in your areas and other organizations, as appropriate.

The details, as well as information on how to RSVP to attend the Washington, DC meeting are below. Future meetings may take place in Seattle, Denver, and Chicago.
