**Notice to Public of Revocation and Cancellation of Approval to Receive Medicare Payment
of Clara SP Chan, MD's CLIA Certificate**

The Centers for Medicare & Medicaid Services (CMS) is providing notice that on December 1, 2018, the Clara SP Chan, MD, located at 9801 Georgia Avenue, Suite #337, Silver Spring, Maryland, 20902, CLIA certificate was revoked due to their failure to meet CLIA requirements. In addition, the cancellation of its approval to receive Medicare payments for its services became effective December 1, 2018.

The laboratory was notified that cancellation of its approval to receive Medicare payments for any laboratory services and its CLIA certificate would be revoked 15 calendar days after receipt of notice, dated November 16, 2018 (effective December 1, 2018). In addition, the laboratory was notified that they had 60 calendar days from receipt of the imposition notice (November 16, 2018) to appeal CMS' imposition of Sanctions (due January 15, 2019). No appeal was filed.

When a laboratory's CLIA certificate is revoked, it is required to cease all patient laboratory testing, including waived and provider performed microscopy testing and regardless of whether or not the laboratory charges for the testing. In addition, CLIA regulations prohibit the laboratory's owner/operator, and its director, Clara Chan, MD., from owning, operating, or directing any laboratory for two years from December 1, 2018, or until December 1, 2020. CMS is committed to patient safety and quality of care.
