Description	Ratio of the number of observed unplanned 30-day hospital readmissions to the number of expected unplanned 30-day hospital readmissions. NQF #2496
Numerator	Number of unplanned 30-day hospital readmissions
Denominator	The expected number of unplanned 30-day hospital readmissions in each facility, which is derived from a model that accounts for patient characteristics, the dialysis facility to which the patient is discharged and the discharging acute care or critical access hospitals involved.
Exclusions	The measure excludes readmissions in the numerator that:  1. Occurred more than 30 days after the index discharge  2. Are considered "planned"  3. Occur within the first three days following discharge from the acute care hospital  The measure excludes index hospital discharges from the denominator that:  1. End in death  2. Result in a patient dying within 30 days with no readmission  3. Are against medical advice  4. Include a primary diagnosis for certain types of cancer, mental health conditions or rehabilitation  5.
