Home Health Quality Reporting Program (HH QRP) Proposed Rule

CMS is proposing to adopt, for the CY 2018 payment determination, four measures to meet the requirements of the <u>IMPACT Act</u>. Three of these measures are resource-based and calculated using Medicare claims. The fourth measure is assessment-based and is calculated using Outcome and Assessment Information Set (OASIS) data. The proposed measures are as follows:

- All-condition risk-adjusted potentially preventable hospital readmission rates
- Total estimated Medicare spending per beneficiary
- Discharge to the community
- Medication reconciliation

Quality of Patient Care Star Ratings TEP Update

Abt Associates recently convened a Technical Expert Panel (TEP) to review the first year of data on the performance of the Home Health Quality of Patient Care (QoPC) Star Ratings. The goals of the TEP were to discuss and make recommendations for revising the Home Health QoPC; and to make recommendations for additional analyses to support ongoing maintenance and improvement of the Home Health QoPC Star Ratings. The second quarterly Quality Assessment Only (QAO) Interim Reports, for OASIS data submitted between January 1 and December 31, 2015, have been posted to the CASPER folders. These reports are informational only and are intended to assist home health agencies monitor their compliance with the annual pay-for-reporting requirements. Agencies are encouraged to closely monitor these Quarterly QAO Interim Reports and investigate any discrepancies or concerns in a timely fashion to assure that all corrections or adjustments occur prior to their receipt of the Annual QAO Metric Report.

The QAO Interim Performance Reports will remain in the CASPER folders for 120 days. The table below shows the reporting schedule for 2016. More information on the QAO performance requirement is available on the <u>Home Health Quality Reporting</u> page.

The OASIS C2 item set is now available in the "Downloads" portion of the OASIS Data Sets <u>web page</u>. This item set version is effective as of January 1, 2017 and includes three new standardized items, along with the modification and renumbering of select medication and integumentary items in order to standardize with other post-acute care settings. In addition, the look back period has been modified for five items, and there are several formatting changes throughout the item set. - Home Health Agencies and the OASIS

As we approach March 2016, we will provide additional reminders. This downtime will affect ALL QIES users. It is critical that affected Providers make the necessary contingency plans to accommodate for this downtime and ensure their data is submitted in a timely manner.

Quality of Patient Care Star Ratings TEP Announcement

The Centers for Medicare & Medicaid Services (CMS) has contracted with Abt Associates to evaluate the methodology for calculating the Quality of Patient Care Star Ratings that appear on the Home Health Compare website, including identifying options for improvement. As part of the process of continually evolving the rating system, CMS asks contractors to convene groups of stakeholders and experts to contribute direction and thoughtful input to the contractor for consideration in the rating system.

A technical expert panel (TEP) is being convened with the objectives of reviewing the first year of data on the performance of the Quality of Patient Care Star Ratings, and gathering feedback on potential refinements to the rating system including usability of the system for patients and advocates. Interim QAO Reports to be Available

CMS is planning to make interim QAO reports available via CASPER that show agency performance against the QAO metric. The first report is scheduled for the end of January 2016 and will be based on assessments completed during the period from October 01, 2014 – September 30, 2015 and submitted by October 30, 2015. These reports will be described during the Home Health Open Door Forum on January 27; they are for informational purposes only, and will not be used for determining pay-for-reporting compliance.
