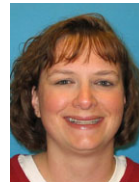

Reena Duseja is the Chief Medical Officer for the Quality Measurement and Value-Based Incentives Group in the Center for Clinical Standards and Quality at CMS. In this role, she oversees measure development and analyses for a variety of CMS quality reporting and value-based purchasing programs. Previously, Reena was the Acting Group Director for the Quality Measurement and Value-Based Incentives Group, and the Director of the Division of Quality Measurement. She is an emergency medicine physician and, prior to coming to CMS, was an Associate Professor in the Department of Emergency Medicine at the University of California, San Francisco, where she led quality improvement activities in a large county hospital and was awarded funding by the National Institutes of Health to conduct studies related to improving patient care and value that our health system delivers to patients. As a Robert Wood Johnson Clinical Scholar at the University of Pennsylvania, her research focused on quality of care and unintended consequences of measurement. She received her M.S. in Health Economics at the University of Pennsylvania.
