### **Introduction and Purpose Goal of Reporting Star Ratings**

- ■Displays of stars are an efficient, familiar, consumer-centric way to communicate relative performance (visual shortcut).
- ■Format addresses the barrier of innumeracy, i.e. it is not necessary to understand or interpret the numbers behind the stars to understand and use them.
- ■CMS Star Ratings are an important tool for empowering consumers, encouraging providers to strive for higher levels of quality, and driving overall health system improvement.



# Introduction and Purpose Monitoring

CMS engages in ongoing monitoring and improvement to the Quality of Patient Care (QoPC) Star Rating methodology to ensure meaningful and accurate comparison across Home Health Agencies (HHAs)



## Introduction and Purpose History of Changes Considered for the QoPC Algorithm

- Medicare Learning Network (MLN) Call on January 19, 2017 included two proposals:
  - Remove measure: Influenza Immunization Received for Current Flu Season (based on Outcome and Assessment Information Set [OASIS] data)
  - Add measure: Emergency Department Use without Hospitalization (claims-based data)
- Stakeholder comments in response to January 19 MLN Call
  - Supported removal of Influenza Immunization Received for Current Flu Season measure
  - Did not support addition of Emergency Department Use without Hospitalization measure



### **Introduction and Purpose**

#### History of Changes Considered for the QoPC Algorithm (con.)

- Announced revised changes to QoPC Star Ratings proposal (October 2017)
  - Remove measure: Influenza Immunization Received for Current Flu Season (OASIS-based)
  - Based on stakeholder feedback, no longer recommended the addition of the Emergency Department Use without Hospitalization measure
- Thirty day comment period: October 11 November 11, 2017



**Background: The Home Health Setting** 

- Over 12,000 HHAs
- 23 quality measures on Home Health Compare (HHC).
  - 7 OASIS-based process measures
  - 7 OASIS-based outcome measures
  - 4 Claims-based utilization measures
  - 5 HHCAHPS-based measures
- Separate star ratings for Quality of Patient Care and Patient Experience (based on survey data from Home Health Consumer Assessment of Healthcare Providers and Systems [HHCAHPS])
- Other existing CMS star ratings programs: Nursing Home Compare, Physician Compare, Dialysis Facility Compare and Hospital Compare



#### **Current QoPC Star Rating**

- HHAs must be able to report 5 of 9 measures to have a star rating computed
- Reporting requires at least 20 episodes of care during the reporting period
   Process (not risk adjusted)
- Timely Initiation of Care
- Drug Education on all Medications Provided to Patient/Caregiver
- Influenza Immunization Received for Current Flu Season

#### Outcome (risk adjusted)

- Improvement in Ambulation
- Improvement in Bed Transferring
- Improvement in Bathing
- Improvement in Pain Interfering With Activity
- Improvement in Dyspnea
- Acute care hospitalization (claims-based)




#### **Summary of Current Methodology**

- 1. For each of the 9 measures, rank all agencies based on score and assign into 10 equally-sized groups (deciles).
- 2. Adjust (or not adjust) the HHA's initial individual measure rating to help distinguish scores that are different from the national median based on a statistical test
- 3. For each agency, average the adjusted ratings across all measures (at least five needed) and round to the nearest 0.5
- 4. Assign ratings from 1 to 5 in half-star increments
- 5. Refer to posted methodology document for more detail



#### Distribution of QoPC Star Ratings: October 2017 Home Health Compare

- 10 quarters of QoPC Star Rating data currently completed
- For the October 2017 HHC refresh, there were 9,194 HHAs (76.6%) reporting with average rating of 3.25





#### **QoPC Star Rating Data Availability Timeline**

- Starting with the October 2017 HHC refresh, HHC displays data that are 9 months lagged for both OASIS and claims-based measures:
  - OASIS data from January 1, 2016 to December 31, 2016
  - Claims data from January 1, 2016 to December 31, 2016
  - Preview reports provided to HHAs in August 2017
- Next refresh of HHC will occur in January 2018
  - Preview reports were provided in October 2017



### Proposed Change to QoPC Star Rating Methodology: Remove Influenza Immunization Measure

#### Influenza Immunization Received for Current Flu Season

- **Description:** Percentage of home health episodes of care during which patients received influenza immunization for the current flu season.
- Numerator: Number of home health episodes of care during which the patient a)
  received vaccination from the HHA or b) had received vaccination from HHA
  during earlier episode of care, or c) was determined to have received vaccination
  from another provider.
- **Denominator:** Number of home health episodes of care ending with a discharge or transfer to inpatient facility during the reporting period, other than those covered by generic or measure-specific exclusions.
- **Exclusions:** Home health episodes care for which no care was provided during October 1–March 31, OR the patient died, or the patient does not meet age/condition guidelines for influenza vaccine.
- Received earlier support for removing this measure in TEP and stakeholder feedback




### Proposed Change to QoPC Star Rating Methodology: Remove Influenza Immunization Measure

#### **QoPC Star Rating Simulation: Remove Flu Measure**

- October 2017: 9,194 HHAs (76.6%) reporting with average rating of 3.25
- Remove Flu: 9,147 HHAs (76.2%) reporting with average rating of 3.27

#### **Distribution of QoPC Star Ratings**





### Proposed Change to QoPC Star Rating Methodology: Remove Influenza Immunization Measure Summary of Impacts

- Very slight decrease in the percent of HHAs that can report a QoPC Star Rating – from 76.6% to 76.2% of HHAs for October 2017
- Slight increase in the QoPC Star Rating from 3.25 to 3.27 on average for October 2017
- Increase in the QoPC Star Rating experienced by both small and large HHAs (in terms of number of episodes in a year) and by both rural and urban HHAs



### Proposed Change to QoPC Star Rating Methodology: Remove Influenza Immunization Measure Summary of Public Comment

- Public comment period: October 11 through November 11, 2017
- CMS received 24 comments
  - All commenters supported the removal of the Influenza measure
- Rationale for supporting removal
  - Differences across states' regulations regarding transporting and administering vaccinations
  - No exclusion made for patients who were offered the vaccination and refused
  - No exclusion made for patients who cannot receive the vaccination due to contraindications



### Proposed Change to QoPC Star Rating Methodology: Remove Influenza Immunization Measure Summary of Public Comment (con.)

- Several commenters emphasized the importance of this measure and supported continued reporting on Home Health Compare.

### Proposed Change to QoPC Star Rating Methodology: Remove Influenza Immunization Measure Final Decision and Implementation Timeline

- CMS will remove the Influenza Immunization Received for Current Flu
   Season measure from the QoPC star rating
  - Removal will be effective with April 2018 Home Health Compare refresh
- This measure will continue to be reported on Home Health Compare to encourage vaccination
- CMS will monitor the Influenza Immunization Received for Current Flu Season measure to ensure rates do not decrease



### Proposed Change to QoPC Star Rating Methodology: Remove Influenza Immunization Measure Final Decision and Implementation Timeline (con.)

- Timeline
  - First preview report using new calculation algorithm: no later than mid-January 2018
  - Home Health Compare refresh displaying updated QoPC Star Rating: April 2018
    - All measures (OASIS- and claims-based) will report on data from July 1, 2016 to June 30, 2017
