Please see below for important updates and information related to the Hospice Quality Reporting Program (HQRP).

#### **Hospice Quality Reporting Program Update**

The Calendar Year (CY) 2019 HQRP began January 1, 2019. Hospice Item Set (HIS) and Consumer Assessment of Healthcare Providers and Systems (CAHPS®) Hospice Survey data from CY 2019 impacts your Annual Payment Update (APU) in Fiscal Year (FY) 2021. To ensure your hospice achieves its full APU, please continue to meet the hospice quality reporting requirements for both HIS and CAHPS® Hospice Survey data.
