Login to the Centers for Disease Control and Prevention (CDC) National Healthcare Safety Network (NHSN) using your provider number.

Note: To ensure all recently entered data are incorporated, generate new data sets from the Analysis, "Generate Data Sets" link. On the Generate Data Sets screen, select the **[Generate New]** button. You will be asked to confirm that existing data sets will be overwritten. Select **[OK]**. When the data set generation process is complete, the "Date Last Generated" field will update.

Once the data sets are generated, you are ready to view your report. Reports are referred to as "Output Options" and are organized in a tree view to guide you toward the data you want. To access the Output Options screen, navigate using the menu pane to Analysis, Output Options.

To access data for NQF #0138 and #0139:

Login to the NHSN Patient Safety Component, navigate using the menu pane to Analysis, Output Options, Advanced, and open the Advanced output options folder. Three separate reports are available from the Advanced output options folder: monthly reporting plan data, event data, and summary data. You can modify these reports in order to select the applicable time period to show when the data were first reported to NHSN.
