Project Overview:

The Centers for Medicare & Medicaid Services (CMS) has contracted with Mathematica Policy Research and its partners to develop, electronically specify, and maintain clinical quality measures for EPs to use in certified electronic health record (EHR) systems for CMS quality programs. The contract name is *Electronic Clinical Quality Measure (eCQM)* Development and Maintenance for Eligible Professionals (EPs). The contract number is HHSM-500-2013-130111, Task Order HHSM-500-T00001. As part of its measure development process, CMS asks contractors to convene groups of stakeholders and experts who contribute direction and thoughtful input to the measure contractor during measure development. The Mathematica project team selected the following 14 people to serve as the technical expert panel (TEP) for this project (Table 1). Some of these experts replace former members of the TEP who have since left the group (Table 2). The TEP is co-chaired by members Erin MacKay and Shannon Sims.
