

**2013 Physician Quality Reporting System (PQRS) and Electronic Prescribing (eRx) Incentive Programs  
Participating Electronic Health Record (EHR) Data Submission Vendors**

CMS is pleased to announce the participating 2013 Data Submission Vendors able to report quality data to CMS, on behalf of eligible professionals, for the 2013 Physician Quality Reporting System program year. The EHR Data Submission Vendors are able to submit PQRS data on behalf of individual eligible professionals (EPs). Some of the 2013 EHR Data Submission Vendors are able to submit Electronic Prescribing (eRx) Incentive Program data on behalf of individual EPs and Group Practice Reporting Option (GPRO) group practices. Some of the 2013 EHR Data Submission Vendors are also able to submit PQRS – Medicare EHR Incentive Pilot data on behalf of individual EPs.
