

## Qualified Electronic Health Record (EHR) Vendors for the 2011 Physician Quality Reporting System and Electronic Prescribing (eRx) Incentive Programs

CMS is pleased to announce the EHR vendors and their system and products (including specific version or release) that have been “qualified” to submit quality data to CMS by eligible professionals for the 2011 Physician Quality Reporting System program year. Each of these EHR vendors has gone through a thorough vetting process to verify that their listed qualified system and product(s) have the capability to provide the required data elements for the 20 Physician Quality Reporting System measures. These 20 Physician Quality Reporting System measures may be found on the “Alternative Reporting Mechanisms” section page of the CMS website, available at <http://www.cms.gov/PQRS>. Some EHRs are also capable of reporting the electronic prescribing (eRx) measure to CMS as listed in the below table. Please note that EHR-based reporting for the eRx measure only applies for reporting of the eRx measure in 2011 for purposes of the 2011 eRx incentive, not for reporting of the eRx measure in 2011 for purposes of the 2012 eRx payment adjustment. In addition to capturing the required data elements for the measure calculation, these “qualified” EHR products can also transmit the required information in the requested file format. While the listed EHR vendors and their qualified EHR system and product(s) have successfully completed the vetting process, CMS cannot guarantee that any other product or version of software, other than what is listed in this document, will be compatible for EHR-based submission for the Physician Quality Reporting System or the Electronic Prescribing Incentive Program.
