

Qualified Registries for the 2011 Physician Quality Reporting System (PQRS) and Electronic Prescribing Incentive Programs

CMS is pleased to announce the registries that have become “qualified” to submit quality data to CMS on behalf of their eligible professionals for 2011 PQRS reporting (see table below). Each of these registries have gone through a thorough vetting process including checking their capability to provide the required PQRS data elements, reviewing a measure flow and algorithms, performance use case calculations (this checks to see whether the registry calculates the measure’s reporting and performance rates correctly), and transmitting the required information in the requested file format (XML). Some registries are also capable of reporting the electronic prescribing measure to CMS as listed in the table below. While the listed registries successfully completed the vetting process, CMS cannot guarantee that any or all of the listed registries will be successful in providing the required information on behalf of their eligible professionals for the possible payment incentive.
