Jason Karlawish, MD, presenter, is a Professor of Medicine, Medical Ethics, Health Policy, and Neurology at the University of Pennsylvania. His research focuses on ethical and policy issues encountered by older adults with late-life cognitive disorders, such as Alzheimer's disease and cognitive aging. He is currently examining the clinical and social impacts of changing concepts of Alzheimer's disease. Dr. Karlawish developed the "Assessment of Capacity for Everyday Decisionmaking (the ACED)," an instrument to assist in decisional capacity assessment, and the "Concept of Healthcare," a novel model to promote cognitive health and maintain wealth with a particular focus on the banking and financial services industries. Dr. Karlawish is also the Co-Director of the Penn Memory Center and the Director of the Healthy Brain Research Center.

Dr. Karlawish earned a Doctor of Medicine degree from Northwestern University.

**Shari Ling, MD, developer/presenter,** is the Deputy Chief Medical Officer (CMO) for the Centers for Medicare & Medicaid Services (CMS) and Medical Officer in the Centers for Clinical Standards and Quality (CCSQ). She assists the CMS CMO in the Agency's pursuit of higher quality health care, healthier populations, and lower cost through quality improvement. Dr. Ling served on

the faculty of the Johns Hopkins School of Medicine for five years before joining the Intramural Research Program of the National Institutes of Health (NIH) at the National Institute on Aging (NIA) as a Staff Clinician. At the NIA, Dr. Ling studied human aging and age-associated chronic diseases with attention to musculoskeletal conditions and mobility function for eight years.

Dr. Ling is also a Gerontologist. She served as the Clinical Services Co-Director of the Andrus Older Adult Counseling Center after receiving her training in direct service from the Leonard Davis School at the University of Southern California.

Dr. Ling earned a Doctor of Medicine degree at Georgetown University School of Medicine.

Simeon Niles, JD, MPH, presenter, joined the Division of Population Health Incentives and Infrastructure (DPHII) in the Prevention and Population Health Group (PPHG) at the Center for Medicare & Medicaid Innovation (CMMI) in December 2014. He is currently the Program Lead for the Accountable Health Communities (AHC) Model. Prior to joining CMMI, he was a Federal Healthcare Consultant in one of the Big Four professional services firms where he provided legal, analytic and project management support to clients by monitoring the development of Federal and State legislation and regulations; and supporting process improvement activities including workflow enhancement of agency clearances.
