Cindy Brach, MPP, presenter, is a Senior Health Care Researcher in The Agency for Healthcare Research and Quality's (AHRQ's) Center for Delivery, Organization, and Markets. In this role, she conducts and oversees research on health systems improvement in the areas of health literacy, cultural and linguistic competence, chronic care, and children's health care. Ms. Brach also leads AHRQ's health literacy activities, coordinating the Agency's work in developing measures, improving the evidence base, and creating implementation tools. Her health literacy projects have included the development of the AHRQ's "Health Literacy Universal Precautions Toolkit," "Making Informed Consent an Informed Choice: Training Modules for Health Care Leaders and Professionals," CAHPS® Item Sets for Addressing Health Literacy, and the Patient Education Materials Assessment Tool (PEMAT).

Ms. Brach serves on the National Academy of Medicine's Roundtable on Health Literacy, where she led an effort to define the attributes of a health literate organization. She is a Subject Matter Expert in cultural and linguistic competence. Her work in this area includes overseeing the development of the "TeamSTEPPS Limited English Proficiency (LEP) Module" and the "Re-

engineered Discharge Toolkit," which addresses the needs of diverse patients. Ms. Brach's work on Medicaid and the State Children's Health Insurance Program (SCHIP) includes overseeing the five-year evaluation of the Children's Health Insurance Program Reauthorization Act (CHIPRA) Quality Demonstration Grant Program. She also worked to improve chronic care, overseeing the development of "Integrating Chronic Care and Business Strategies in the Safety Net: A Toolkit for Primary Care Practices and Clinics," and co-authoring the "Primary Care Practice Facilitation Curriculum."

Ms. Brach is a frequent speaker at National conferences and webinars. She has published book chapters and articles in journals, such as Health Affairs, the Journal of General Internal Medicine (JGIM), the Journal for Healthcare Quality, the Journal of Health Communication (JHQ), Medical Care, Medical Care Research and Review (MCRR), and Pediatrics. She is a Founding Member of the Editorial Board of Health Literacy Research and Practice. Ms. Brach's earlier experience includes serving as a Mental Health Policy Research Director, a Welfare Reform Consultant, Provider of Technical Assistance, a State-Level Administrator, and a Municipal Policy Analyst.

Ms. Brach earned her Master of Public Policy degree from the University of California, Berkeley, where she also advanced to Doctor of Philosophy (PhD) degree candidacy.
