Peter Budetti is Deputy Administrator for Program Integrity of the Centers for Medicare and Medicaid Services (CMS), US Department of Health and Human Services, and Director of the CMS Center for Program Integrity. He has principal responsibility for program integrity policies and operations in the Medicare and Medicaid Programs. Before joining CMS, Dr. Budetti worked in a number of health care positions in government and the private sector.

Dr. Budetti's previous government service includes six years as Counsel, Subcommittee on Health and Environment, U.S. House of Representatives, under the Chairmanship of Congressman Henry A. Waxman. He was also a member of the professional staff, Senate Finance Committee, under the Chairmanship of Senator Daniel Patrick Moynihan and was a core legislative drafter for President Bill Clinton's Health Security Act. In his academic life, he founded and directed health policy research centers and held tenured professorships at Northwestern University and The George Washington University, and was a member of the faculty of the Philip R. Lee Institute for Health Policy Studies, University of California, San Francisco. Immediately before his appointment at CMS in February, 2010, Dr. Budetti had been the Edward E. and Helen T. Bartlett Foundation Professor of Public Health, Department of Health Administration and Policy, College of Public Health, University of Oklahoma, for over six years. During the 2009-2010 academic year he was on sabbatical, working with the National Association of Insurance Commissioners in Washington, D.C., on antifraud initiatives. Dr. Budetti was a member and long-time Chairman of the Board of Directors of Taxpayers Against Fraud (TAF), a nonprofit, public interest organization dedicated to combating fraud against the Federal Government.

Dr. Budetti's medical degree is from Columbia University College of Physicians and Surgeons; law degree from Boalt Hall, University of California, Berkeley; and undergraduate degree from the University of Notre Dame. A board-certified pediatrician and member of the California Bar (inactive), he was elected to the National Academy of Social Insurance in 1996. He is married and has two grown children, a son- and daughter-in-law, three grandsons, three granddaughters, and two small doggies.

Shantanu Agrawal is a Board-certified Emergency Medicine physician and Fellow of the American Academy of Emergency Medicine. He is currently the Medical Director of the Center for Program Integrity (CPI) at the Centers for Medicare and Medicaid Services (CMS). CPI's mission is to reduce and eliminate waste, abuse, and fraud in Medicare and Medicaid. Prior to joining CMS, Dr. Agrawal worked for McKinsey and Company, where he served mainly provider and payer clients in the public and private sectors. His work focused on improving hospital quality, clinical resource utilization, physician alignment, and performance management. Dr. Agrawal completed his clinical training and education at the Hospital of the University of Pennsylvania and Cornell University Medical College. He also has a Masters degree from Cambridge University, where his published dissertation focused on U.S. welfare reform during the Clinton administration. Dr. Agrawal continues to work clinically in Washington DC.
