The Physician Compare public reporting plan was finalized in the 2012, 2013, 2014, and 2015 [Physician Fee Schedule \(PFS\) Final Rules](#). Any measure finalized as “available for public reporting” in the PFS final rule may be included on Physician Compare. However, only those measures that are statistically comparable, valid, and reliable and that meet the established public reporting criteria, including the minimum sample size of 20 patients, will be published on the site. All measures submitted, reviewed, and deemed valid and reliable will be publicly reported via a downloadable database on data.medicare.gov. Only those measures that are deemed most useful and best understood by consumers will be included on Physician Compare profile pages. Individual EPs will be given a 30-day preview period to view their measures as they will appear on Physician Compare prior to the measures being published. The specific measures available for public reporting for 2014, as well as Million Hearts measures for 2015 data are listed below.

2014 EHR, registry, and claims measures

- Heart Failure (HF): Beta-Blocker Therapy for Left Ventricular Systolic Dysfunction (LVSD)
- Medication Reconciliation
