

# Group Performance Information on Physician Compare Performance Year 2017

## Overview

This document summarizes the group performance information and plain language measure titles<sup>1</sup> that will be publicly reported on Physician Compare in early 2019. Physician Compare will publicly report group performance information from the 2017 Quality Payment Program. Information may be publicly reported on group profile pages or only in the Downloadable Database. Measures that meet statistical public reporting standards (valid, reliable, comparable, and meet the minimum reliability threshold) will be added to the Downloadable Database (§414.1395(b)). A subset of this information will be added to Physician Compare profile pages. Any information publicly reported on profile pages must also resonate with patient and caregivers, as shown through user testing. Per the Medicare and CHIP Reauthorization Act (MACRA), Physician Compare is required to publicly report eligible clinicians’ final scores and performance category scores.
