

## Income Guidelines for HMK

If the number of people living in your home (adults and children) is:	Your family can earn up to this amount and may qualify for HMK:
2	\$37,825
3	\$47,725
4	\$57,625
5	\$67,525
6	\$77,425
7	\$87,325
8	\$97,225

Children may be eligible for HMK even if family income is more than the amount listed. There are income deductions for employed parents and dependent care expenses.

### How do I apply for HMK Plan?

- ✓ Call 338-2524 and an appointment can be set up for you at the office or at your home.
- ✓ Your application will be filled out and sent on-line.
- ✓ Once approved, the CHIPRA program will develop a tracking system for contacting enrolled children and will assist in re-enrollment each year.

## Healthy Montana Kids



### What's the Healthy Montana Kids Plan?

- ✓ A plan that offers low-cost or free health coverage for children and teenagers up to age 19.

### Children may qualify for HMK if:

- ✓ The children are Montana residents, U. S. citizens or qualified aliens; and
- ✓ A child can qualify for HMK based on family size and income.

### What's the cost?

- ✓ There are no co-payments for Native American children covered by HMK (Health Montana Kids) and they may receive services from any participating provider, including Indian Health Service (IHS) and Tribal Health providers.
- ✓ Families pay no monthly premiums or deductibles.
- ✓ Some parents may pay a small co-payment when care is received; however, they never pay more
