

Have kids?

If you have a child under the age of 19 and live in a household with limited to moderate income (up to \$4362 adjusted monthly gross for a family of 5) then you are likely eligible for no-cost coverage through Nebraska's Kids Connection.

Did you know that even if you receive services through IHS (Indian Health Services) or CHS (Contract Health Services), you should apply for Kids Connection. Funding for these agencies is very limited, so they ask that you use any and all other available resources first. Kid's Connection is one of those resources.

Ponca Tribe has specialized Case Workers (CMCWs) who will help you apply and qualify.

It's simple and takes very little time.


