## DMEPOS Information for Pharmacies

To supply Durable Medical Equipment, Prosthetics, Orthotics, and Supplies (DMEPOS), a pharmacy must obtain either of the following:

- **Accreditation** from an independent national Accreditation Organization (AO) approved by the Centers for Medicare & Medicaid Services (CMS)
- **Exemption** from the National Supplier Clearinghouse (NSC)

**Please note:** The information in this publication applies only to the Medicare Fee-For-Service Program (also known as Original Medicare).



This publication provides information for pharmacies seeking an exemption.

To enroll or maintain Medicare billing privileges, all non-exempted DMEPOS suppliers must comply with the DMEPOS Quality Standards and obtain accreditation. Find more information in the [DMEPOS Quality Standards](#) and [DMEPOS Accreditation](#) publications.

## Pharmacy Accreditation Exemption

A pharmacy that meets **all** of the following criteria may file an [accreditation exemption statement](#) to supply DMEPOS without accreditation.



## New Locations

New locations must obtain accreditation because they do not meet the second requirement of having been enrolled in the Medicare Program as a DMEPOS supplier for at least 5 years. Therefore, new locations within chains or independent newly opened locations must obtain accreditation.

### Change of Ownership

Pharmacies that changed owners in the prior 5 years, which changed their legal business entity and Taxpayer Identification Number (TIN), do not qualify for an accreditation exemption.
