



Medicare Learning Network® (MLN) Disclaimers, Trademarks, and Taglines

Definitions:

- Footnote – an explanatory or documenting note or comment at the bottom of a page, referring to a specific part of the text on the page
- Notice – an announcement of information
- Statement – an abbreviated announcement of information
- Disclaimer – an assertion that disclaims responsibility; please note, disclaimers use the term “web” instead of “internet.”

If the MLN product is reviewed and there are no changes to the content, use the date the content was cleared again and include the following language in the disclaimer section:

“As of the date on this product, the content was reviewed and it was determined that no changes were necessary and that the content remains current.”

Below are the MLN content disclaimer, MLN product disclaimer, as well as the trademark ownership and tagline information that must appear, in one form or another, on all products. When there is a link to disclaimer language, the product owners must use the link to the disclaimer language. The product owner will not write out the disclaimer language if there is an available link to the disclaimer language.

We will not link to the following: trademark ownership and tagline; or copyright notices.

Some of the verbiage below has two versions:

- Version “a” spells out all language
- Version “b” links to the disclaimer language and spells out the remaining language

1a. MLN Language

The headings (Content Disclaimer, Product Disclaimer, as well as the Trademark Ownership and Tagline) are for your information only. Do not use the headings in the products.

2. Co-branding Language (Note: CMS only co-brands with MACs.)

3a. CPT-AMA Language

The headings (Copyright Notice, Copyright Statement, Trademark Statement, Government Rights Statement, and Disclaimer) are for your information only. Do not use the headings in the products.

The full set of notices and disclaimers (1. Copyright Notice, 2. Copyright Statement, 3. Trademark Statement, 4. Government Rights Statement, and 5. Disclaimer) should appear (once) in the beginning of the document that contains CPT. The copyright statement is repeated as a footer on each page where CPT appears. This notifies the reader who may be looking at just one page that some of the content included in the government document is privately owned.

Whether a document includes:

- CPT codes only
- CPT codes and descriptions, or
- HCPCS Level I content (whether it is labeled HCPCS or CPT)

The verbiage that goes along with the three bolded titles (Background, Reproduction, and Copyright) are all CMS instructions. Do not include the instructional language in the product.
