2009 H1N1 & Seasonal Influenza

Key Points - 2009 H1N1 & Seasonal Influenza - Oct 09

- The 2009 H1N1 vaccine situation changes rapidly – throughout each day, vaccine is being shipped from the vaccine manufacturers to McKesson distribution centers; orders are coming into McKesson; orders are being processed and shipped; and vaccine is arriving in thousands of places across the country.

- McKesson, the distributor for the 2009 H1N1 vaccine, is increasing the number of delivery sites from 90,000 to 150,000.

As of Friday, October 9, all states and the District of Columbia have placed orders for 2009 H1N1 vaccine, and more orders are expected daily.

- While the national picture reveals good supply and rapid distribution, local areas may not have received as much seasonal vaccine as they anticipated at this point in the season and providers seeking additional vaccine now may be unable to purchase it. - Approximately 77 million doses of seasonal flu vaccine have been distributed, as of October 2, 2009. This is approximately 61% of the doses that are expected to be distributed for this season.


