Reminder: Open Enrollment Continues Until March 31, 2014:

Consumers have until March 31, 2014 to enroll for coverage through the Marketplace during this open enrollment period. We will continue to work to ensure that HealthCare.gov and our other enrollment channels continue to improve and are available for consumers looking to sign up for affordable coverage by the end of March and will continue to keep you updated with the latest

information. Consumers that enroll in coverage by March 31, 2014 will not have to pay the individual responsibility payment for the time that they are without health insurance coverage in 2014.

Please also remind consumers that if they want health insurance to begin on February 1, they will need to enroll by January 15. If they sign up between January 16 and February 15 their coverage won't begin until March 1.
