I. GENERAL INFORMATION

A. Background: This recurring update notification provides the payment allowances for the following seasonal influenza virus vaccines: CPT codes 90654, 90655, 90656, 90657, 90661, 90662, 90672, 90673, 90685, 90686, 90687, and 90688, and HCPCS codes Q2033, Q2035, Q2036, Q2037, and Q2038, when payment is based on 95 percent of the Average Wholesale Price (AWP).

The Medicare Part B payment allowances below apply for the indicated effective dates:

CPT 90655 Payment allowance is \$17.243. Effective dates: 8/1/2013-7/31/2014

CPT 90656 Payment allowance is \$ 12.398. Effective dates: 8/1/2013-7/31/2014

CPT 90657 Payment allowance is \$ 6.022. Effective dates: 8/1/2013-7/31/2014

CPT 90661 Payment allowance is pending. Effective dates: 8/1/2013-7/31/2014

CPT 90685 Payment allowance is \$ 23.228. Effective dates: 8/1/2013-7/31/2014

CPT 90686 Payment allowance is \$ 19.409. Effective dates: 8/1/2013-7/31/2014

CPT 90687 Payment allowance is pending. Effective dates: pending-7/31/2014

CPT 90688 Payment allowance is pending. Effective dates: pending-7/31/2014

HCPCS Q2035 Payment allowance is \$ 11.543. Effective dates: 8/1/2013-7/31/2014

HCPCS Q2036 Payment allowance is \$ 8.579. Effective dates: 8/1/2013-7/31/2014

HCPCS Q2037 Payment allowance is \$ 14.963. Effective dates: 8/1/2013-7/31/2014

HCPCS Q2038 Payment allowance is \$ 12.044. Effective dates: 8/1/2013-7/31/2014

HCPCS Q2039 Flu Vaccine Adult - Not Otherwise Classified payment allowance is to be determined by the local claims processing contractor with effective dates of 8/1/2013-7/31/2014.

Payment allowances for codes for which products have not yet been approved (including but not limited to CPT codes 90687 and 90688) will be provided when the products have been approved and pricing information becomes available to CMS.

Payment for the following CPT or HCPCS codes may be made if the local claims processing contractor determines its use is reasonable and necessary for the beneficiary, during the effective dates indicated below:

CPT 90654 Payment allowance is \$ 18.918. Effective dates: 8/1/2013-7/31/2014

CPT 90662 Payment allowance is \$ 31.823. Effective dates: 8/1/2013-7/31/2014

CPT 90672 Payment allowance is \$ 24.596. Effective dates: 8/1/2013-7/31/2014

HCPCS Q2033 Payment allowance is pending. Effective dates: 8/1/2013-12/31/2013

CPT 90673 Payment allowance is pending. Effective dates: 1/1/2014-7/31/2014

The payment allowances for pneumococcal vaccines are based on 95 percent of the AWP and are updated on a quarterly basis via the Quarterly Average Sales Price (ASP) Drug Pricing Files.

B. Policy: The Medicare Part B payment allowance limits for influenza and pneumococcal vaccines are 95 percent of the AWP as reflected in the published compendia except where the vaccine is furnished in a hospital outpatient department, Rural Health Clinic (RHC), or Federally Qualified Health Center (FQHC). Where the vaccine is furnished in the hospital outpatient department, RHC, or FQHC, payment for the vaccine is based on reasonable cost.

Annual Part B deductible and coinsurance amounts do not apply. All physicians, non-physician practitioners and suppliers who administer the influenza virus vaccination and the pneumococcal vaccination must take assignment on the claim for the vaccine.
