I. GENERAL INFORMATION

A. Background: This Recurring Update Notification provides instructions for the calendar year (CY) 2014 Payment Rate Increases for Rural Health Clinics (RHC) and Federally Qualified Health Centers (FQHC) services that can be found in Chapter 9, section 20 of the IOM. RHCs: The RHC upper payment limit per visit is increased from XX.XX to XX.XX effective January 1, 2014, through December 31, 2014 (i.e., CY 2014). The 2014 rate reflects a X.X percent increase over the 2013 payment limit in accordance with the rate of increase in the Medicare Economic Index (MEI) as authorized by §1833(f) of the Social Security Act. FQHCs: The FQHC upper payment limit per visit for urban FQHCs is increased from XXX.XX to XX

B. Policy: This effective date of January 1, 2014, is necessary in order to update RHC and FQHC payment rates in accordance with 1833(f) of the Social Security Act. To avoid unnecessary administrative burden, the contractor shall not retroactively adjust individual RHC/FQHC bills paid at previous upper payment limits. The contractor does, however, retain the discretion to make adjustments to the interim payment rate or a lump sum adjustment to total payments already made to take into account any excess or deficiency in payments to date.
