

# Eligible Hospital and Critical Access Hospital EHR Incentive Program Objectives and Measures for 2015 Objective 6 of 9

Date issued: October 6, 2015

Patient-Specific Education	
<b>Objective</b>	Use clinically relevant information from CEHRT to identify patient-specific education resources and provide those resources to the patient.
<b>Measure</b>	More than 10 percent of all unique patients admitted to the eligible hospital's or CAH's inpatient or emergency department (POS 21 or 23) are provided patient specific education resources identified by CEHRT.
<b>Alternate Exclusion</b>	Provider may claim an exclusion for the measure of the Stage 2 Patient Specific Education objective if for an EHR reporting period in 2015 they were scheduled to demonstrate Stage 1 but did not intend to select the Stage 1 Patient Specific Education menu objective.

## Definition of Terms

**Patient-Specific Education Resources Identified by CEHRT** – Resources or a topic area of resources identified through logic built into CEHRT which evaluates information about the patient and suggests education resources that would be of value to the patient.

**Unique Patient** – If a patient is admitted to an eligible hospital's or CAH's inpatient or emergency department (POS 21 or 23) more than once during the EHR reporting period, then for purposes of measurement, that patient is only counted once in the denominator for the measure.

## Attestation Requirements

### DENOMINATOR/NUMERATOR/ THRESHOLD/ALTERNATE EXCLUSION

- **DENOMINATOR:** Number of unique patients admitted to the eligible hospital or CAH inpatient or emergency departments (POS 21 or 23) during the EHR reporting period.
- **NUMERATOR:** Number of patients in the denominator who are subsequently provided patient-specific education resources identified by CEHRT.
- **THRESHOLD:** The resulting percentage must be more than 10 percent in order for an eligible hospital or CAH to meet this measure.
- **ALTERNATE EXCLUSION:** Provider may claim an exclusion for the measure of the Stage 2 Patient Specific Education objective if for an EHR reporting period in 2015 they were scheduled to demonstrate Stage 1 but did not intend to select the Stage 1 Patient Specific Education menu objective.

## Additional Information

- Unique patients with office visits means that to count in the denominator a patient must be admitted to the eligible hospital or CAH inpatient or emergency departments (POS 21 or 23) during the EHR reporting period, but if a patient is admitted to the eligible hospital or CAH inpatient or emergency departments (POS 21 or 23) more than once during the EHR reporting period, the patient only counts once in the denominator.
- The eligible hospital or CAH must use elements within certified EHR technology (CEHRT) to identify educational resources specific to patients' needs. Certified EHR technology is certified to use the patient's problem list, medication list, or laboratory test results to identify the patient-specific educational resources. The eligible hospital/CAH may use these elements or may use additional elements within CEHRT to identify educational resources specific to patients' needs. The eligible hospital or critical access hospital can then provide these educational resources to patients in a useful format for the patient (such as, electronic copy, printed copy, electronic link to source materials, through a patient portal or PHR).
- The education resources or materials do not have to be stored within or generated by the CEHRT.
- There is no universal "transitive effect" policy in place for this objective and measure. It may vary based on the resources and materials provided and the timing of that provision. If an action is clearly attributable to a single provider, it may only count in the numerator for that provider. However, if the action is not attributable to a single provider, it may be counted in the numerator for all providers sharing the CEHRT who have the patient in their denominator for the EHR reporting period.
- The action may reasonably fall outside the EHR reporting period timeframe but the numerator includes the qualifier "subsequently" which indicates the patient-specific education resources must be provided after the patient's admission to the hospital and no later than the date of attestation in order to count in the numerator.
- A provider may use an alternate calculation for an EHR reporting period in 2015 if that calculation is part of their CEHRT.
- Please note, for 2015, eligible hospitals and CAHs may use an EHR reporting period from the beginning of the federal fiscal year to the end of the calendar year (October 1, 2014 through December 31, 2015). For eligible hospitals and CAHs, the action may occur at any point during that time so long as it is no earlier than October 1, 2014 and no later than the date of attestation for their 2015 EHR reporting period.

## Certification and Standards Criteria

Below is the corresponding certification and standards criteria for electronic health record technology that supports achieving the meaningful use of this objective.

Certification Criteria*	
<b>§ 170.314(a)(15) Patient-specific education resources</b>	EHR technology must be able to electronically identify for a user patient-specific education resources based on data included in the patient's problem list, medication list, and laboratory tests and values/results: <ul style="list-style-type: none"> <li>(i) In accordance with the standard specified at § 170.204(b) and the implementation specifications at § 170.204(b)(1) or (2); and</li> <li>(ii) By any means other than the method specified in paragraph (a)(15)(i) of this section.</li> </ul>

*\*Depending on the type of certification issued to the EHR technology, it will also have been certified to the certification criterion adopted at 45 CFR 170.314 (g)(1), (g)(2), or both, in order to assist in the calculation of this meaningful use measure.*
