

CMS 2014 CEHRT Flexibility Rule Decision Tool

Background:

The CMS 2014 CEHRT Flexibility Rule allows providers to meet Stage 1 or Stage 2 of meaningful use with EHRs certified to the 2011 or 2014 Edition criteria or a combination of both Editions for an EHR reporting period in 2014.

Only providers who have been unable to fully implement 2014 CEHRT can take advantage of the rule's flexibility options.

Purpose:

This tool will guide you through the rule's participation options.

Note:

Beginning in 2015, all eligible providers are required to report using 2014 Edition CEHRT.
