Eliminating the reimbursement program for school administration expenditures and costs related to transportation of school age children between home and school will create a serious problem for schools and charter schools in particular. which is why I am writing. The revenue that we receive from Medicaid reimbursement - approximately \$30k last year - helps us to balance our budget in the "special ed and 504" areas, as we provide services to school-age children. These services include physical and speech therapy in the school setting, so it relates to what they are doing, concentrated, i.e. one on one services for some students in reading and evaluation of their progress. The time spent by special education teachers and the special education director is critical to "school working" for these students in need. Please remember they are IN SCHOOL, not at home, waiting for a taxi to go to an outpatient rehab facility. But this is still "critical care" for these students. Keeping track of this time and the evaluation time as well, if you want to call that "administrative scrvices" - well - some of it is time spent on documentation for you, and the students record, but it is part of the "services," no different than if the students were clients at a "special education" school. Having the students. "kids" in their local schools, with their peers, is critical. The financial support from Medicaid is critical. as certainly "state aid" does not fund the budget totally, and a charter school cannot "ask for an over-ride" from the families. Please reconsider this elimination of reimbursement...our children are our future. and these kids need ALL of the help that they receive . their records and files show that. They can become contributing, successful, proud working citizens - with "the help of the village" that raises the child. Please do not withhold your part. Thank you. I am writing to express my opposition to the regulation proposed by the Centers for Medicare and Medicaid Services published in the Federal Register (CMS 2287-P) that would eliminate school-based reimbursements now paid with Medicaid funds. This rule would negatively impact services to our special needs students - including medical needs, practitioner availability, and transportation to access various services. (Have you tried to employ a Physical Therapist, Occupational Therapist or Speech-Language Pathologist recently? Did you know the average cost in our area for contracting these services is from \$70 - \$90 per hour, plus travel?) While I am certain there has been misuse and abuse of the services - and this should certainly be monitored and corrected,I am concerned about the legitimate needs of children that will go unmet because of the reduction of funds for the school system. Our Exceptional Children's Department depends on the reimbursed funds to help serve the 1,300+ students on our case load. I acknowledge that some superintendents have 'padded' their general funds with these reimbursements, but many school systems have used these monies to increase direct services to students - that has certainly been my experience in Wilkes County. I acknowledge the need for a balanced and realistic budget, but unless this funding cut is going to be accompanied by a reduction in the accountability and responsibility under IDEA 2004 AND a federal mandate to reduce services to children, this proposal to reduce funding is imprudent. Honestly, as a 20+ year veteran of public education, I am not sure how much more we can 'tighten our belts' and still serve our special needs children effectively. Without a paired proposal to reduce services to children the only reasonable message I can send is to urge the withdrawal of CMS 2287-P for consideration.

I wrge that the proposed rule change which would eliminate all school-based Medicaid dollars NOT be implemented. The current level of funding which supports Family Access Network (FAN) in Deschutes County is much needed. What began as a pilot program for effective administration of Medicaid dollars has demonstrated the capacity to attract private funds to serve more families. For example, last year our church held a fair to raise money for non profits in our community. We donated \$1,000 to FAN because this organization has established itself as the best central point in our community to address a whole variety of needs of low income families. Furthermore, our church has asked FAN to identify needy families to receive holiday food and gifts from our congregation. FAN has created a network of partners to help address the needs of children in low income families. For example, FAN has established an arrangement with a local thrift store to provide donated used clothing to children. Every year, thousands of dollars worth of new clothing from Columbia Sportswear is donated to FAN to be distributed to lowincome families. This is a good investment because children who are ready to learn at school have a better chance of becoming productive citizens. The FAN model which depends on teachers to identify kids with needs works well. The FAN advocate can also tell the family of the child about other federal and state program for which they qualify. We urge that the proposed rule change NOT be implemented. The current level of funding should be continued.
