JUSTIFICATION FOR CHANGE

Section 508 of the Rehabilitation Act requires that institutions receiving federal funds solicit, procure, maintain and use all electronic and information technology (EIT) so that equal or alternate/comparable access is given to federal employees and members of the public with and without disabilities. Updating the XLC templates to a Section 508 compliant format will enable CMS and its contractors to produce compliant documentation more efficiently. This reduces the time, effort, and cost associated with creating compliant documentation.
